



Safety Protocols

Health Screening

All visitors and staff are subject to a temperature screening. We kindly ask that you refrain from visiting if within the past 14 days you have experienced COVID-19 symptoms, have tested positive, or have knowingly been in contact with someone who has tested positive or has experienced COVID-19 symptoms. Visitors who have arrived from a state designated by New York State as having significant COVID-19 transmission are required to quarantine for 14 days.

An inherent risk of exposure to COVID-19 exists in any public place where people are present. People visiting the New-York Historical Society do so at their own risk.

Hygiene

Hand sanitizers are available throughout the building. Maintenance staff performs enhanced cleaning throughout the day.


Face Masks & Social Distancing

Photography
